**MANDATORY DECLARATION**  
**FOR ALL PASSENGERS, OFFICERS, AND CREW MEMBERS**

ALOHA! Welcome to the 50th State. Many plants and animals, found nowhere else in the world, have evolved in our islands because of Hawai'i's mild climate and relative isolation in the Pacific. Other plants, animals, and diseases – that commonly occur in other states and countries – could be harmful to our community, agriculture, and unique environment. We ask for your help in keeping Hawai'i safe and beautiful by keeping out harmful pests and diseases. You are required by state law to fill out this declaration form. (Front section only)

- This declaration may include your spouse and any children under 18 years of age accompanying you.

**A) I HAVE THE FOLLOWING ITEMS ON THIS TRIP:**

- Fresh Fruits & Vegetables
- Cut Flowers & Foliage
- Rooted Plants & Plant Cuttings, or Algae
- Raw or Propagative Seeds or Bulbs
- Soil, Growing Media, Sand, etc.
- Live Seafood (lobsters, clams, oysters, etc.)
- Cultures of Bacteria, Fungi, Viruses, or Protozoa
- Insects, Fishes, Amphibians, etc.

**B) I HAVE THE FOLLOWING ITEMS ON THIS TRIP:**

- Dogs
- Cats
- Birds
- Reptiles (Turtles, Lizards, Snakes, etc.)
- Other Animals

If you are traveling with any of the above live animals, you must notify a cabin attendant prior to deplaning.

Submit all above marked items for inspection to the Hawai'i Plant Quarantine inspector in the baggage claim area.

Any person who defaces the declaration form, gives false information, or fails to declare restricted articles in their possession, baggage, or cargo manifest shall be in violation of Chapter 150A of the Hawai'i Revised Statutes and may be guilty of a misdemeanor punishable by a maximum penalty of \$25,000 and/or one year imprisonment.
