(PROPOSED) ORDER ADOPTING AMENDMENTS TO CHAPTER 4-71A,  
HAWAII ADMINISTRATIVE RULES, aka MICROORGANISM IMPORT RULES,  
TO DELETE THE FUNGI, PHOLIOTA NAMEKO AND PLEUROTUS ERYNGII,  
FROM THE LIST OF RESTRICTED MICROORGANISMS, (PART A)  
AND (PART B), RESPECTIVELY, AND TO ADD THESE FUNGI  
TO THE LIST OF NONRESTRICTED MICROORGANISMS

The Hawaii Board of Agriculture (Board), pursuant to section 150A-6.6,  
Hawaii Revised Statutes, section 4-71A-17, Hawaii Administrative Rules  
(Rules), and the Board's approval at its duly noticed meeting on (above  
date), hereby adopts the proposed amendments to: (1) delete the fungus,  
Pholiota nameko, from the List of Restricted Microorganisms (Part A), Chapter  
4-71A, Rules; (2) delete the fungus, Pleurotus eryngii, from the List of  
Restricted Microorganisms (Part B), Chapter 4-71A, Rules; and (3) add the  
fungi, Pholiota nameko, and Pleurotus eryngii, to the Chapter 4-71A Rules'  
List of Nonrestricted Microorganisms, as shown in the (proposed) exact  
changes appended as Appendix A. This order is subject to the approval of the

Governor, State of Hawaii, and the public notice requirements of section 4-71A-17, Rules, and shall take effect ten days after such notification.
